- **All food vendors** must submit a certificate of insurance listing the Sodus Chamber of Commerce. This waiver does not have to be submitted with the application; however, it must be on file with the committee by the event date.
- **All food vendors need a NYS Dept of Health, Geneva district, permit. A home processor permit is not valid.**
- **We request that all vendors cooking food have a fire extinguisher in their booths. Fire inspection from any fire marshal or code certified personnel for all food trucks.**
- We do not guarantee the same spot as last year. If you have a request, please state it in on your application.
- Please bring the necessary equipment to hold down your booth if there are winds. Stake downs are not allowed since booths are on pavement.
- Pets are not allowed at this event
- Collecting and reporting Wayne County NYS sales tax is the responsibility of each vendor.
- The Harvest Fest Committee reserves the right to remove objectionable material or pull vendor applications the day of the event without a refund. This is a family/community event.
- The Town of Sodus, Sodus Chamber of Commerce, and the Harvest Fest Committee will not be held responsible for lost, stolen, or broken items. They are also not responsible for any mishaps pertaining to the vendor's personal items, booth, and or products being sold.
- This is a rain or shine event and refunds will not be given
